New Byrne Justice Assistance Grant Opportunity

## **REQUESTED ACTION:**

We request permission to apply for and enter into an MOU with Crook County for another round of Byrne JAG monies. The application must be approved by City Council and the MOU must be signed by the CEOs of both Crook County and the City of Prineville.

## **BACKGROUND:**

For several years, the City of Prineville has received Byrne Grant monies. These monies can be spent to further law enforcement purposes. Typically, these monies have been in small amounts (around \$10,000) and we have used the monies to complete small projects, like Information Technology upgrades or for the purchase of equipment. Additionally, we have entered into cooperative agreements with Crook County Sheriffs Office in at least the three last grant cycles on how to best spend the money. As we have in years past, we are not opposed to working cooperatively with CCSO on projects that further the mission of law enforcement in this area.

This year, we are slated to receive \$19,505.00. There is no match and the monies can be spent over the next four years. The application deadline is July 9<sup>th</sup>, 2009. A requirement of the application process is Council approval at least 30 days prior to application submission.

We propose spending a large portion of the monies for a new digital Department Manual. We had hoped to purchase the manual through prior grants, but other priorities kept this from happening. We may also direct a portion of the monies towards additional equipment or upgrades. Crook County SO will likely use a portion of the monies for equipment or upgrades.

## **FISCAL IMPACT:**

There is no negative fiscal impact. This grant will allow us to meet needs that have been pending for years.

**RECOMMENDATION:** Staff requests this request be approved.
