<u>Issue Summary Report:</u> City of Prineville Council Meeting August 25th, 2009

<u>Topic:</u> Resolution 1112, an Intergovernmental Agreement with the Oregon Department of Transportation (ODOT) regarding Analysis and Design of the 9th St Extension.

Overview:

The ODOT Intergovernmental Agreement No. 25374 authorizes the State (ODOT) to pay the City of Prineville up to \$490,000.00 for the preliminary analysis, engineering and design work for the continuation of 9th St from Main Street to the City of Prineville Railway right-of-way and from the Railway right-of-way to NE 7th St.

These funds are included in the adopted City of Prineville budget. \$200,000.00 is budgeted in the current fiscal year with the remaining \$290,000.00 budgeted in the next fiscal year. There are no match requirements due by the City of Prineville.

Recommendation:

Staff recommends that the City of Prineville Council enter into Intergovernmental Agreement No. 25374 and authorize the Mayor to sign such agreement on behalf of the City of Prineville.

RESOLUTION NO. 1112

A RESOLUTION AUTHORIZING ENTERING INTO AN INTERGOVERNMENTAL AGREEMENT CONCERNING NORTH NINTH STREET EXTENSION

WHEREAS, the City of Prineville's transportation system plan sets out the extension of North Ninth Street as an arterial roadway in the City's transportation system; and

WHEREAS, because of a lack of funds the City has been unable to complete the design for the extension of North Ninth Street; and

WHEREAS, the State of Oregon acting by and through its Department of Transportation (hereinafter "State") has prepared Intergovernmental Agreement No. 25374 regarding Analysis and Design of Arterial Roadway for Ninth Street Extension in the City of Prineville; and

WHEREAS, pursuant to the terms of the Agreement the State will pay to the City up to \$490,000 for the preliminary analysis, engineering, and design work for the continuation of North Ninth Street from Main Street to the City of Prineville Railway right-of-way and from the Railway right-of-way to Seventh Street; and

WHEREAS, City staff believes it is in the best interests of the City to enter into the Intergovernmental Agreement;

NOW, THEREFORE, it is hereby resolved that the City of Prineville agrees to enter into Intergovernmental Agreement No. 25374 with the State and authorizes the Mayor to sign such Intergovernmental Agreement on behalf of the City of Prineville.
