Mr. Daly informed the Council of the Prineville's airport improvements over the last several months. Mr. Daly also offered his phone number and invited anyone who would like to come up and see the airport to give him a call.

A. Appointment of Member for Local Public Safety Coordinating Council

Carl Dutli, City Attorney briefly explained the purpose of this organization and the ORS requirements.

Council President Roppe recommended waiting until the Mayor was present at the next meeting and wanted additional information such as frequency, etc. Council agreed to postpone until the next meeting.

A. Managers Report – Steve Forrester

Steve Forrester stated that: the City was awarded the Silver Safety Award at the League of Oregon Cities conference; staff and Council took a tour at Ladd Marsh wetlands in LaGrande with ODF & W and Bret Moore from Anderson Perry; Dinner train has been running both Saturday and Sunday the last two weekends; Oregon Irrigation District met with Senator Merkley's staff and discussed some HCP items; attended DWA kickoff meeting on October 12th with Senator Walden staff; Liz Schuette and Steve are reviewing quarterly reports and will have report available at the November 10th meeting; and thanked Council for the opportunity to attend the LOC conference.

B. Goals 5, 6 & 7 Status Report – Scott Edelman

Scott Edelman, Senior Planner presented a power point that summarized the process this item has gone through up to this time. Scott Edelman explained that there will be no further input for this Ordinance coming October 27th, since the public portion of the hearing for this has been closed. The only additional input would be to verify that the attachments accurately reflect the Planning Commission's and Council's final decision.

C. 2nd Street Egress Project – Scott Smith

Scott Smith, Street Supervisor presented the staff report, stating that the paving for this project should be complete by October 30th, 2009.
