Staff Reports:

A. Managers Report – Steve Forrester

Steve Forrester stated that: He attended an Emergency Preparedness class in Salem; the Crook County Booster Club painted a total of 446 fire hydrants around town which benefited the City by saving money and benefited high school sports teams; had a conversation with a site selector regarding a smaller data center with a time frame of 2012; Roger Jordan, LOC Range Rider used City of Prineville and staff as a successful example of collaboration; and Jim Adams of Oregon Emergency Management gave kudos to city staff.

Steve Forrester read the November 2nd City of Prineville Election results into the record as follows: Betty Jean Roppe won the vote for Mayor with 57.67%; Dean Noyes as Council member with 31.64%; Jack Seley as Council member with 31.22%; and Stephen Uffelman as Council member with 35.27%.
