RE: Enterprise Zone Expansion

Mayor Roppe & council members,

In order to enhance the inventory of industrial land served by the Crook County Enterprise Zone, I am requesting that an additional 1,607 acres be included. It is the opinion of Economic Development for Central Oregon (EDCO), that the enterprise zone offers an important and competitive incentive tool that helps our efforts in recruiting and retaining businesses. Facebook is an obvious example. In your council packets, I have submitted a map and a description of each of the parcels to be included.

**State law** requires that rural enterprise zones be no larger than 15 square miles. Currently, the Crook County Enterprise Zone is 6.4 square miles, and with the additional 1,607 acres, it will increase to 8.9 square miles, well below the state cap.

**State law** requires that all zone sponsors of an enterprise zone approve any boundary changes by a majority vote and a written resolution supporting the action. Both the Prineville City Council and Crook County Court are zone sponsors.

Once signed by the council, the necessary documentation will be forwarded to the State of Oregon for final approval. I respectfully request that you support this action.

NOW THEREFORE, the City of Prineville resolves as follows:


