Council Business:

A. Budget Committee Appointments

Ms. Morgan stated that one of the applicants has since withdrawn their application for the Budget Committee due to family health reasons.

Mayor Roppe asked applicant Bruce Peet to introduce himself.

Mr. Peet provided Council with his professional background as well explaining his interest to serve on the Budget Committee.

Councilor Uffelman made a motion to appoint Paul Slater and Bruce Peet the Budget Committee. Motion seconded. No discussion on motion. All in favor, motion carried.

Staff Reports:

A. Managers' Report – Steve Forrester

Mr. Forrester stated: the Chamber lease is complete and should be taking over the old Railroad office on February 1st, 2014; Matt continues to work with Historical Society on the agreement for the Shay locomotive that includes the Historical Society paying for the cost of upkeep; rail traffic up slightly in February due to new shippers on line; the Pension Obligation Bonds have been successfully completed; Captain Boyd and team reported the neighborhood cleanup went well with over 5 tons disposed of; met with the Facebook Energy Manager to discuss renewable energy possible projects; Public Works had a public outreach meeting with stakeholders regarding realignment of Tenth Street; Erickson Air asked for an extension from the 6th to the 20th of February at the Airport for training 13 pilots; and there were reports from Mike Warren, Real Estate of Record distributed to Council regarding the property requested for bike park.

Councilor Carr commented that he would like to see a real estate report like this on all city owned property.

B. Meadow Lakes Update – Zach Lampert

Zach Lampert, Golf Pro, presented a power point presentation that highlighted revenues this time of year versus same time last year over the last couple of years.

There were questions regarding gift certificate sales and fixing the cart paths.

Mr. Lampert stated that the sales of gift certificates goes into a liability account and are not counted as revenue until they are redeemed. The repairing of the cart paths are expected to begin in the spring.
