B. Mayor's Report

Mayor Roppe announced that she was appointed to the Oregon Mayor's Association Board of Directors effective January 1, 2014.

Mayor Roppe provided information on a statewide contest coming up for "If I Were Mayor" and went through the different age groups to be considered. Mayor Roppe will get information on the contest out to the schools and asked Council if they were willing to consider types of prizes that could be awarded to the winners at the local level.

Councilor Uffelman recommended a prize could be to become a "Honorary Mayor" for a day.

Council agreed to give it some thought and bring ideas back at the next Council meeting.

A. Managers' Report – Steve Forrester

Mr. Forrester stated: he participated in the first emergency vehicle operation training and asked Captain Boyd to provide more information.

Captain Boyd provided a summary of the training adding that the new police vehicles performed great in the snow.

Mr. Forrester continued with announcing an Airport Master Plan meeting will be held here at City Hall tomorrow at 2:00 P.M.; the Sports Complex Committee has met twice now and has split into smaller subgroups to gather additional information with setting aside the entertainment portion of the plan for now and focusing on the sports; Eric Klann, City Engineer and himself have met with Iron Horse to negotiate the connection of Combs Flat Road; and Mr. Klann and himself attended a One Stop Funding meeting in Salem today to discuss the wetlands project, which was very well received.

Mr. Forrester asked for a snow removal update. Mr. Klann and Scott Smith, Street Supervisor provided Council with an update and numbers associated with the snow removal.

Public Works logged 266 hours with 215 at an overtime rate; the other 51 hours were from Eric Klann, Pat Goehring and Steve Forrester working snow removal. All but 3 employees were called in; 284 cubic yards of cinder were used, which is 3 times the amount of cinder used during the last 5 years.

Liz Schuette, Finance Director and Lori Hopper, Finance Assistant presented the quarterly report for period ending December 31, 2013.
