Re: Annual Prineville Disposal Rate Adjustments

Background:

April 23rd, the Public Works Committee met with Steve Holliday of Prineville to go over the annual financial statements.

This last year, Prineville Disposal focused on efforts to "true up" the rate structure used, rather than seeking a "blanket" across the board fee increase. Rates have been lined up with item charges based on the type of services a customer may need. For example, if a customer needs a lock for a dumpster, that cost is now associated directly to that customer rather than across the customer base.

These changes will appear on the customer statements as an additional line item depending on the type of additional accessory services requested by the customer. Though this may result in an increase to some customers requesting additional service items, over all the proposed change in the rate structure are expected to decrease Prineville Disposal's overall revenue by 3%.

Prineville Disposal is not requesting approval for a rate increase, but is requesting approval for the new rate structure, which is further improving the accuracy in billing methods.

Recommendation:

The Public Works Committee recommends approving a Resolution, approving Prineville Disposal's new rate schedule structure.

Overview

In 2013 Prineville Disposal operations experienced an increase in revenue and a decrease in expenses which lead to a positive overall net income. We are very pleased this year to be able to "true up" some of our line item accessory rates, instead of a blanket overall rate structure increase. This action will lead to a 3% decrease with the rates that the changes are applied. Most all current rates will not change.

Revenues

2013 showed a slight increase in overall revenues. There was a better than expected increase in both commercial and residential revenue. Recycling revenue was significantly down again due to a continual depressed commodities market. With a CPI rate increase of 2.3% last year we were able to increase our overall revenue by 6%.

Expenses

2013 overall expenses experienced a slight decrease. There are a few different expenses that experienced decreases. The areas were payroll and benefits, and property insurance. Property taxes decreased this year due to the correction of an oversight last year, this year should be closer to a normal cost. Most other expenses are unchanged with some expenses being slight changes.
