REQUESTED ACTION:

The Police Department requests permission to sell, trade, or destroy property left over from closed cases in accordance with Ordinance Sections 33.04, 33.05 and 33.06.

BACKGROUND:

The Prineville Police Department takes in numerous items each year. Some items are evidence, some are found property and some turned over by citizens. Items taken as evidence are returned to the rightful owners whenever possible. In some cases, the items are not reclaimed by the owners for many reasons (we cannot locate the owner, the owner no longer wants the item(s), the owner has been reimbursed by their insurance and the insurance company does not want the item, etc.). All items in this request that were seized as evidence have been cleared for release / disposal by the Crook County District Attorney's Office.

We must periodically clear out our evidence room in order to make room for new incoming items. Prineville City Ordinances require Council approval to sell (33.04), transfer (33.05) or dispose of (33.06) property. We will track the final lawful disposition of all listed items.

FISCAL IMPACT:

Any monies from items sold will go to the General Fund. Items transferred for City use will reduce or eliminate costs to purchase similar items. Any items destroyed or safely disposed of will be virtually cost free and disposal costs are factored into the regular PPD budget.
