# A. Police Department Award of Purple Heart to Sgt. Jimmy O'Daniel

Interim Police Chief Stiles asked Sgt. Jimmy O'Daniel and wife, Heather O'Daniel to come forward.

### A. Request for Funding - Crook County Connect & Beyond - Rich Mires

Rich Mires explained that they are trying to raise money for an event they plan on September 17, 2015 for homeless people to receive various benefits.

There were discussions regarding all the benefits that are going to be offered and the dollar amounts associated with each of them.

Councilor Seley made a motion to contribute \$3,000 to Crook County Connect & Beyond. Discussion on motion.

Councilor Carr made a motion to amend motion to contribute \$2,000 to Crook County Connect & Beyond specific to medical expenses. Motion seconded. No discussion on motion. All in favor motion carried.

Council President Uffelman asked for vote on original motion as amended. No discussion. All in favor, amended motion carried.

#### B. Intent to Award Purchase of Street Sweeper - Scott Smith

Scott Smith, Street Supervisor presented the staff report.

There were discussions regarding life cycle of street sweepers, and expected delivery date.

Carl Dutli, City Attorney added that council is considering the purchase piece of the sweeper tonight and the financing part of the sweeper will come back at the next meeting.

Mr. Forrester stated: A Downtown Strategic Planning Committee will be this Thursday at 3:30 to 5:00 P.M.; development is up in subdivision lot sales; Barnes Butte Elementary open house is August 21<sup>st</sup> at 5:30 P.M.; Mayor Roppe received the Oregon Mayor's Association Leadership Award; staff met with Rural Development regarding letter of conditions for wetland project funding; and Scott Smith has stated that the sidewalk project on Third Street by Robberson Ford has commenced.

Phil Stenbeck came forward and explained that he is hoping to have a second council workshop on HB 3400 and other bills as it relates to marijuana prior to the next council meeting on August 25<sup>th</sup>.
