Staff Reports and Requests:

A. Manager's Report – Steve Forrester

Mr. Forrester reported: that the Mayor, Eric and himself went to Vancouver, Washington and met with Bonneville Power representatives in person, and just received official notice today that the Prineville project came on line; the public notice for the supplemental budget will be published; Public Works has spring and summer projects going, and 2nd Street was paved today in front of the new jail; the new public safety building information has been released with positive feedback so far, and will be followed up with media output and a neighborhood meeting on July 2nd; and the EDCO luncheon was very well attended.

Councilor Rodriguez was at the post office and heard how much a citizen liked the 2nd Street paving.

B. Committee Reports

Mayor Uffelman attended an Ochoco Forest Collaborative meeting which talked about fire hazards and the last Salem VTEL meeting took place last week.

Ordinances:

A. Ordinance No. 1252 – Vacation of Unimproved Portion of Right Way of NE Buckboard Lane in the Buckhorn Acres Subdivision (FIRST PRESENTATION) (PUBLIC HEARING) – Josh Smith

Josh Smith, Planning Director provided background information that included previous discussions with Council regarding this.

There were no questions.

Mayor Uffelman opened the public hearing portion of the meeting.

Mr. Everest expressed concerns regarding the street, traffic and quality of life with the apartment project.

Mr. Smith explained that vacating this portion of the unimproved right of way will prevent traffic from the apartments entering into the existing neighborhood, and that it will be gated which only the Fire Department will be able to use in the event of an emergency.

Discussions continued regarding the future plans to extend Peters Road to Combs Flat Road, enabling traffic an alternate direction other than down Main Street which will also help when that happens.
