Added additional item to Executive Session to discuss real property.

Consent Agenda

Councilor Roppe made a motion to approve Consent Agenda. Motion seconded. No discussion. All in favor, motion carried.

Visitors, Appearances and Requests:

- A. Emily and Steve Holiday of Prineville Disposal presented their annual report.
- B. CCHS & NJROTC provided information regarding their standing in competitions and have opportunity to compete in Nationals. They requested support from City Council to help them get to the National competition. Council unanimously agreed to table decision for donation until the April 14th City Council meeting.
- C. Niva Bennett, Partnership Specialist for U.S. Census Bureau gave presentation regarding the upcoming 2010 Census.
- D. Cascade East Transit did a presentation that addressed questions Councilors had from their prior visit in seeking a contribution for operations from City Council.
