Councilor Noyes opposed. Motion carried.

D. Appoint Budget Committee Member

Don Wee whose term expired December 31, 2008, expressed an interest in serving on the Budget Committee for another term. Councilor Uffelman made a motion to appoint Don Wee to the Budget Committee. Motion seconded. No discussion on the motion. All in favor, motion carried.

A. Wayne Van Matre, Interim City Manager stated there is a copy of the proposed fees for FY 2009/2010 for Council to review prior to the budget hearing. Mr. Van Matre provided the Council with an update on the refinancing progress that was discussed in January. Mr. Van Matre pointed out the requests for contributions from Ochoco Humane Society and CCHS Metal Shop class, and a form regarding nominations for a volunteer award. Mr. Van Matre discussed the City's response to ODOT regarding the Tom McCall / Hwy 126 interchange. Ricky Sites presented the staff report.
