Captain Boyd provided the background regarding the Volunteers in Policing (VIP) Academy and the training / requirements that the graduates went through. Steve Forrester, City Manager came forward and read the oath to swear in the volunteers

A. COACT Report – Steve Forrester, City Manager passed out information explaining the purpose and mission of COACT.

Scott Smith, Streets Supervisor, provided information regarding Prineville specific projects recognized on the State Transportation Improvement Project (STIP) list due to the support of COACT.

Manager's Report Steve Forrester stated that: Cascade East Transit (CET), Parks & Recreation and the City, met regarding a temporary bus stop location; 2nd Street project is moving along well and on track; Lynn Blvd. overlay will be in progress September 2nd & 3rd using stimulus funds; the Humane Society of the Ochoco;s, Mr. Lynch, staff and business consultant met with an update report to be available for Council in September; Jason Carr has had communication for a data center interested in Crook County; and Project Vitesse continues to move ahead positively. Mr. Forrester than provided a recap of the staff's research trip in Eastern Oregon regarding wetlands. Captain Boyd came up to provide an update on maintenance of property under foreclosure. Mr.Forrester announced that Scott Edelman, Senior Planner and his wife just had their second son this week; staff is meeting with David Porter of EDA at wetland site for possible future construction funding; Councilor Roppe and Mr. Forrester have a tour at Bowden Dam with staff from the Senator's office.
