City Council Meeting Brief March 22nd, 2011

Additions to the Agenda

Mayor Roppe asked to add Mayor's Report under Council Business.

Consent Agenda

Councilor Seley was not present at the March 8th, 2011 meeting.

Councilor Noyes made a motion to approve Consent Agenda as amended. Motion seconded. All in favor, motion carried.

Visitors, Appearances and Requests:

- A. Karole Stockton came forward to provide background information for the proclamations on the agenda.
- B. Councilor Noyes made an announcement that Wednesday, March 30th, Scott Edelman would be doing a presentation at the "What's Brewing" meeting.

Council Business:

A. Intent to Award Spring Water Line Replacement Project – Jerry Brummer

Jerry Brummer, Public Works Superintendent presented the staff report.

Councilor Gillespie made a motion for intent to award the Spring Water Line Replacement Project to A.G. Ontko Contracting of Powell Butte, Oregon for \$143,012.50. Motion seconded. No discussion on motion. All in favor, motion carried.

B. Request for Funding - Crook County High School Rodeo Club

Councilor Noyes provided the background information for this request as well as an update on the various rodeo events here this year.

Councilor Gillespie applauded the efforts of the Fair Board in bringing in these events.

Councilor Seley made a motion approving a \$2,000 donation to the Crook County High School Rodeo Club. Motion seconded. No discussion on motion. All in favor, Councilor Noves abstained, motion carried.

C. Draft Resolution Discussion to Establish Policy for Proclamations and Displaying Information on Banners – Carl Dutli

Carl Dutli, City Attorney explained that he would like to remove the section regarding banners on the proposed resolution due to a recent court case against Tri-Met.

The Council discussed Councilor Uffelman's suggestion.

The resolution will be brought back at the next Council meeting with the banner portion removed to look into further.

Councilor Noyes made a motion to approve proclamation requests from the Domestic Violence Awareness Group. Motion seconded. No discussion on motion. All in favor, motion carried.

D. Mayor's Report - Mayor Roppe

Mayor Roppe stated that: There will be an "If I Were Mayor" contest this year; March 30th is COCO day at the Capital, Councilor Beebe agreed to attend; and provided a Deschutes Water Alliance (DWA) update and asked Council to consider a contribution to DWA.

Councilor Gillespie made a motion to contribute \$2,000 to DWA. Motion seconded. No discussion on motion. All in favor, motion carried.
