## B. Prineville/Crook County Airport

Carl Dutli, City Attorney provided Council with the background on the temporary agreement before them.

There were discussions between Council on the importance of the airport's infrastructure to future economic development and Councilor Noye's correspondence regarding the City taking over management of the airport.

Council agreed that the date to come up with the final agreement should be changed, so that it could be discussed and considered at the September 27<sup>th</sup> Council meeting.

## C. Run to the Cascades Event Update - Chief Bush

Chief Bush came forward and provided Council with an update regarding number of people anticipated, the parade route and OLCC temporary license. Mayor Roppe read a letter from an organization that is planning an event that they hope will tie in with this one.

Chief Bush then provided an update for weed abatement and water savings on the Police Department's new HVAC system.

Steve Forrester stated that: the solar projects that the city worked on with the County is moving forward; Senator Merkley and his senior staff are scheduled tentatively to be here August 24<sup>th</sup>; Project Cloud is looking at another location that has jumped ahead of Prineville in ratings; Project Cowboy continues dialogue with City and County; City is engaged in a cooperative effort with Jefferson County regarding 911 Dispatch centers; the Merritt barbeque is tomorrow evening where Congressman Walden is expected to attend; and Chief Bush is in line for a promotion to Brigadere General in September.

Mayor Roppe added that the Governor has created a solutions team and has appointed Mayor Roppe as the large cities representative.
