CALL TO ORDER:

Planning Commission Chair Marty Bailey called the Commission to order.

Public Hearing:

A. SUB-2012-100 Buckhorn Acres (Continued from April 17th)

Staff gave a presentation on the revised proposal from the April 17th meeting. Staff restated the purpose of the proposal and discussed the code language that makes it possible. The presentation showed the revised right-of-way extensions to the north and the increased park area dedication from 1.5 acres to 2 acres. The presentation also went through the difference between right-of-way and easements, citizen concerns from the previous meeting as well as different development scenarios from single family homes to additional subdivisions and what improvements would be required with each. Staff finished the presentation explaining the Planning Commission options to either: agree that remaining lots are of sufficient size to defer public improvements and approve the subdivision as written, approve with additional conditions or deny the application.

The applicant explained that his reasoning for the proposal was to make lots more affordable in today's environment for individual investors. He also admitted that these lots could end up single family home sites for quite some time before future subdivisions would be viable, which was a concern of City staff. The applicant did not object to dedicating the right-of-way with this proposal although he said he would prefer not to.

Two citizens from the neighborhood to the north spoke:

Arnald Favabaugh spoke in general terms about how he sees this property developing out and cited a few verbal guarantees about how this area would develop that were never truly guaranteed. In this way he was in favor of the right-of-way dedication and believed someday this area would just be another postage stamp subdivision.

Ronnie Ralls spoke in opposition to extending the right-of-way north to Buckboard lane

The Planning Commission had very little debate after all questions had been answered. Don Wood made a motion to approve as revised and written in the staff report. Deb Harper seconded the motion and the motion passed 6 for and 1 against.
