Additions to the Agenda

Legacy Games – Second Hand License added to consent agenda.

Councilor Seley made a motion to approve consent agenda as presented. Motion seconded. No discussion on motion. All in favor, motion carried.

Visitors, Appearances and Requests:

A. Jail Overview – Sheriff Hensley

Sheriff Hensley provided a power point presentation that illustrated the current jail and how it is used; Jefferson County Jail; as well as the budgetary impacts to their general fund

Council Business:

A. Intent to Award Railway Junction Installation of Site Lighting – Toby Van Altvorst

Mr. Forrester stated: the TSP Advisory Committee meeting will be September 20th at 2:00 P.M.; League of Oregon Cities (LOC) annual conference is the last week of September; Central Oregon Cities Organization (COCO) had a legislative summit on September 5th with several state law makers present; Economic Development of Central Oregon (EDCO) interview panel narrowed search down to four (4) good candidates; the Safe Routes to School is on schedule; and Brian Harmon, Public Works Superintendent was asked to come forward.

Mr. Harmon read his resignation letter to the Council, and thanked them for the opportunity given to him here at the city.
