Water

Water SDCs are based on water meter size. Previous use may be credited toward final SDC. Refunds on water SDCs are not allowed.

2025/26 Water SDC Per Equivalent Dwelling Unit (EDU) 810/day = **\$6,391.23**

Wastewater

Wastewater SDCs are based on water meter size. Previous use may be credited toward final SDC. Refunds on wastewater SDCs are not allowed.

Transportation

Transportation SDCs are calculated per the Institute of Transportation Engineers (ITE) Trip Generation Manual 11th Edition, based on the PM peak hour trip generation of adjacent street traffic, or by an approved Trip Generation study performed by a registered professional engineer.

The last previous usage of a facility may be used as a credit toward final SDC. Refunds on traffic SDC's are not allowed.

2025/26 Transportation SDC per PM Peak Hour Trip = **\$5,956.71**

Parks (Residential only)

The City collects Parks SDCs for the Parks District. The amount is controlled by the Parks Board and may be changed at anytime.

2025/26 Parks SDC per (EDU) = **\$4,557.91**
2025/26 Parks SDC per (EDU) Multi-family, 3 or more units = **\$4,241.39**
