

**RESOLUTION NO. 1418
CITY OF PRINEVILLE, OREGON**

A RESOLUTION EXERCISING THE POWER OF EMINENT DOMAIN

Whereas, the City of Prineville (“City”) may exercise the power of eminent domain pursuant to ORS 35.205 through ORS 35.415, and the laws of the State of Oregon generally, when the exercise of such power is deemed necessary by the City’s governing body to accomplish public purposes for which the City has responsibly; and

Whereas, City has the responsibility of providing storm drainage through the City for the safety and wellbeing of its citizens; and


Whereas, the property described in Exhibit A, attached to this resolution and incorporated herein, hereinafter referred to as “Property,” is abandoned property within the City with no owner of record;

Whereas, to further accomplish the city’s responsibility of providing storm drainage to its citizens, it is necessary to acquire the interest in the Property.


Now, Therefore, the City of Prineville resolves the following:

1. The foregoing statements of authority and need are, in fact, the case. The project or projects for which the property is required and is being acquired are necessary and in the public interest.
2. The power of eminent domain is hereby exercised with respect to the property described in Exhibit A, and is subject to procedural requirements of Oregon law.
3. The City Attorney is authorized and requested to file suit with the Circuit Court of Oregon, Crook County, to commence and prosecute condemnation proceedings under ORS 32.245(1).
4. City expressly reserves its jurisdiction to determine the necessity or propriety of any acquisition, its quantity, quality, or locality, and to change or abandon any acquisition.
