## ORDINANCE NO. 692

AN ORDIMANCE SUBMITTING TO THE VOTERS OF THE CITY OF PRIMEVILLE AND TO THE VOTERS OF CERTAIN TERRITORY OUTSIDE THE CITY THE QUESTION WHETHER THE TERRITORY SHALL BE ANNEXED TO THE CITY; MAKING PROVISION FOR THE ELECTIONS; AND DECLARING AN EMERGENCY.

WHEREAS, it is found by the City Council of the City of Prineville that it would be in the public interest for certain territory described below to be annexed;

NOW THEREFORE, The people of the City of Prineville ordain as follows:

Section 1. <u>Annexation area</u>. The City Council of the City of Prineville proposes that the territory described below be annexed to the City upon approval of the annexation by the registered voters of the city and the registered voters of the territory:

Section 2. <u>Submi</u> on to Election. The question other the territory shall be annexed to the city shall be submitted to the registered voters of the city and to the registered voters of the territory at elections to be held from 8 o'clock a.m. daylight savings time until 8 o'clock p.m. daylight savings time, July 20, 1972.

Section 3. <u>Notice of Elections</u>. The City Recorder shall give notice of the election in the manner required by ORS 222.130. The published notice of the election shall appear in the Central Oregonian, a newspaper of general circulation in the territory and the City. The notice shall state the question to be submitted to the voters, contain a legal description and map of the boundaries of the territory, and invite the registered voters of the territory and of the City to vote on the question.

Section 4. <u>Polling Places</u>. The polling places for the elections shall be as follows, and the notice of the elections shall designate them as such:

- (1) Crook County Court House First Floor Precincts Nos. 1, 8, 10 and 14
- (2) Crook County Court House Basement Precincts Nos. 2, 3 and 6
- (3) Les Schwab Tire Service Center E. Ochoco Highway Precincts Nos. 5, 15 and 17.
- (4) Assembly of God Church Crestview Precincts 4, 13 and 16

Section 5. <u>Election Officers</u>. The following persons are hereby appointed Judges and Clerks of Election at the polls listed opposite their names.

The foregoing judges and clerks shall each take and subscribe before an officer authorized to administer oaths, or the chairman, that he will honestly and faithfully discharge his duties as election judge or clerk. In case of absence or inability of any judge or clerk so appointed to act at the election, the judges and other clerks present at the prescribed time shall, viva voce, choose a qualified registered voter for the election to act in his place. Such substitute must also take and subscribe to an oath.

Section 6. <u>Ballots for Elections</u>. The City Attorney shall prepare a ballot form and ballot title appropriate for the elections, and the City Recorder shall supply the officers at the elections the ballots necessary therefore.

Section 7. Inasmuch as it is necessary for the health, safety and welfare of the City of Prineville that this ordinance go into effect immediately after its passage, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the City Council and approval by "the Mayor.

Yancey Subdivision; thence along the boundary of said lot south 62° 03' east 218.4 feet; thence cast 60 feet; thence north 42° 03' east 240 feet; thence north 63° 31' east 220 feet; thence east 224.3 feet; thence north 20 feet; thence north 14° 52' east 415 feet to the northwest corner of Lot 29; thence east 665 feet more or less to the northeast corner of Lot 29; thence south 461 feet to the southeast corner of Lot 29 which point is 1619 feet east and 2309 feet south of the northwest corner; thence east 102 feet; thence north 38° 30' east 543 feet more or less; thence north 51° 30' west 96 feet; thence north 38° 30' east 47 feet; thence north 51° 30' west 232 feet; thence north 38° 30' east 53 feet; thence north 51° 30' west 38 feet; thence north 38° 30' east 100 feet to the south right of way of the City of Prineville Railway; thence south 51° 30' east 741 feet; thence south 44° 22' east 960 feet more or less to an intersection with the east-west centerline of Section 51; thence east along said centerline 570 feet more or less to the west boundary of Crook County Cemetery, said west boundary being 1437 feet west of the east section line; thence north 493 feet along said west boundary; thence east 473 feet; thence north 947 feet; thence west 373 feet; thence north 150 feet; thence east 1336 feet to the west section line of Section 32; thence south 0° 24' west 334.6 feet to the north boundary of the City of Prineville; thence north 89° 59' east 1686.25 feet; thence north 1335.25 feet to the north section line of Section 31; thence south 89° 35'east 950 feet along said section line to the north quarter corner of Section 32; thence south along the centerline of said Section  $\overline{3}2$  to the centerof the section which is also the northerly boundary of the City of Prineville; which is south 89° 39' east 1,217.0 feet; thence south 36° 38' east, 220 feet; thence south 41° 06' west 45.5 feet; thence south 1,106.6 feet along the east 1/16 line of Section 32 from the point of beginning.

Section 2. <u>Submis</u> on to Election. The question w ther the territory shall be annexed to the city shall be submitted to the registered voters of the city and to the registered voters of the territory at elections to be held from 8 o'clock a.m. daylight savings time until 8 o'clock p.m. daylight savings time, July 20, 1972.

Section 3. <u>Notice of Elections</u>. The City Recorder shall give notice of the election in the manner required by ORS 222.130. The published notice of the election shall appear in the Central Oregonian, a newspaper of general circulation in the territory and the City. The notice shall state the question to be submitted to the voters, contain a legal description and map of the boundaries of the territory, and invite the registered voters of the territory and of the City to vote on the question.

Section 4. <u>Polling Places</u>. The polling places for the elections shall be as follows, and the notice of the elections shall designate them as such:

- (1) Crook County Court House First Floor Precincts Nos. 1, 8, 10 and 14
- (2) Crook County Court House Basement Precincts Nos. 2, 3 and 6
- (3) Les Schwab Tire Service Center E. Ochoco Highway Precincts Nos. 5, 15 and 17.
- (4) Assembly of God Church Crestview Precincts 4, 13 and 16

Section 5. <u>Election Officers</u>. The following persons are hereby appointed Judges and Clerks of Election at the polls listed opposite their names.

The foregoing judges and clerks shall each take and subscribe before an officer authorized to administer oaths, or the chairman, that he will honestly and faithfully discharge his duties as election judge or clerk. In case of absence or inability of any judge or clerk so appointed to act at the election, the judges and other clerks present at the prescribed time shall, viva voce, choose a qualified registered voter for the election to act in his place. Such substitute must also take and subscribe to an oath.

Section 6. <u>Ballots for Elections</u>. The City Attorney shall prepare a ballot form and ballot title appropriate for the elections, and the City Recorder shall supply the officers at the elections the ballots necessary therefore.

Section 7. Inasmuch as it is necessary for the health, safety and welfare of the City of Prineville that this ordinance go into effect immediately after its passage, an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the City Council and approval by the Mayor.
