ORDINANCE NO. 1017

AN ORDINANCE FORMING EAST THIRD STREET LOCAL IMPROVEMENT DISTRICT, DESCRIBING ITS BOUNDARIES, PROCEEDING WITH IMPROVEMENTS AND INTERIM FINANCING, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF PRINEVILLE ORDAIN AS FOLLOWS:

Whereas, by Resolution No. 783 passed January 9, 1995, Prineville City Council declared its intention to place a sewer line to serve real property on the North and South sides of East Third Street; and

Whereas, under said Resolution, Notice was to be given to effected property owners; and

Whereas, said Notice was given by publication in the Central Oregonian Newspaper on January 12, 1995; and

Whereas, a Hearing was held on January 24, 1995; and

Whereas, there were no remonstrances to the project.

NOW THEREFORE,

- 1. The City Council hereby declares that the East Third Street Local Improvement District is hereby formed. The lots or parts of lots benefitted by the improvements to be made are described on the described on the attached Exhibit A and made a part hereof by reference.
- 2. The City Manager is directed to proceed with the improvements. The City Manager is directed to obtain interim financing for the project.
- 3. It being necessary for the health, safety, and welfare of the City of Prineville that this Ordinance go into effect immediately after its passage, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect from and after its passage by the City Council.
