WHEREAS, certain real property identified in "Exhibits A and B" of Resolution No. 821 and commonly identified as the D&E Wood Products properties were annexed into the City of Prineville on August 12, 1997; and

WHEREAS, pursuant to Resolution No. 822, a public hearing was held on the issue of withdrawing said real properties from said districts; and

WHEREAS, there was no objection to withdrawing said properties from the Crook County Vector Control and Zone II Fire Districts; and

WHEREAS, the City Council, pursuant to ORS 222.524, is desirous of formally withdrawing said real properties from said districts as being in the best interest of the City.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF PRINEVILLE ORDAIN AS FOLLOWS:

Section 1. That the real properties identified in "Exhibits A and B" of Resolution No. 821 attached hereto and incorporated herein, are hereby withdrawn, pursuant to ORS 222.524, from the Crook County Vector Control District and the Crook County Zone II Fire District.

Section 2. Neither the City, nor said real properties withdrawn, shall be charged by the Crook County Vector Control District and/or the Crook County Zone II Fire District with any future liabilities, obligations, functions or assessments for the operation of said districts.

<u>Section 3.</u> The public hearing shall be on the 9th day of September, 1997 at 7:00 p.m. at the Prineville City Hall, located at 400 East 3rd Street, Prineville, Crook County, Oregon.

<u>Section 4.</u> Notice of the date, time, place and purpose of the hearing shall be published once each week for two consecutive weeks prior to the date of the hearing in a newspaper of general circulation in the City and shall be posted in four public places in the City for a like period.






