## **ORDINANCE NO. 1211**

## AN ORDINANCE NAMING TWO ALLEYS

The Prineville City Council makes the following findings:

1. At the request of Crook County 911 Emergency Services, the City of Prineville filed an application with the Crook County Building Department Addressing Division to name the alleys connected to NE Apollo Rd. and NE Colleen Rd. This request is for the purpose of more accurately locating the vehicle access point for the homes fronting on Main St. whose vehicle access is off of one of these alleys.

As part of the application, the City of Prineville must give approval 2. because the properties affected by the naming of the alleys are located within Prineville city limits.

3. All properties fronting on Main St. with their sole vehicle access to one of these alleys will have their addresses changed from their current half street address off of Main St. to an alley address.

A public hearing on the application was held before the City Council on 4. January 27, 2015.

5. On February 10, 2015, the Prineville City Council approved the application to name the alley connected to NE Apollo Rd., NE Apollo Alley, and to name the alley connected to NE Colleen Rd., NE Colleen Alley.

BASED UPON the above findings, the people of the City of Prineville ordain as follows:

The alley designated NE Apollo Alley on the map attached as Exhibit A is hereby named NE Apollo Alley and the alley designated as NE Colleen Alley on Exhibit A is hereby named NE Colleen Alley.
