**RESOLUTION NO. 1206(A)**

**A RESOLUTION APPROVING A SOLID WASTE FRANCHISE RATE INCREASE**

RECITALS:


- A. Holliday Enterprises, LLC, holds the exclusive franchise to operate solid waste collection services within Prineville city limits.
- B. Pursuant to City Ordinance No. 1142, prior to Holliday Enterprises, LLC, raising its rates charged within the City of Prineville, a public hearing and resolution of the Prineville City Council is required.
- C. Holliday Enterprises, LLC, proposed a rate increase of 2.3% effective July 1, 2013, for all its customers within the City of Prineville. The fee increase was based upon a 2.3% increase in the consumer price index.
- D. The Prineville City Council held a public hearing on the proposed rate increase on April 23, 2013, and approved the 2.3% rate increase.

NOW, THEREFORE, the City of Prineville resolves as follows:


1. That the rates of Holliday Enterprises, LLC, for services provided pursuant to City Ordinance No. 1142 within the city limits of Prineville, Oregon, and as shown on Exhibit A to this Resolution, are approved effective July 1, 2013. Such rates shall remain in effect until changed by the Prineville City Council.

2. This rate increase is allowed pursuant to Section 11 of Prineville City Ordinance No. 1142.


Resolution No. 1206 was assigned twice in error to two different resolutions and passed.
