## A RESOLUTION PROVIDING INTERIM FINANCING FOR THE CONSTRUCTION OF CITY HALL

WHEREAS, Oregon Revised Statute 294.460 allows local governments to loan money from one fund to another meeting certain criteria, and

WHEREAS, the "Letter of Conditions" dated May 8, 2002, and sent by the United States Department of Agriculture, who is the agency providing the bulk of the funding for the new City Hall/Plaza/Police Re-model project; requires the City of Prineville to expend owners contribution of " $\$ 196,500$ " on actual construction costs before other funding is to be made available, and

WHEREAS, the City of Prineville and Crook County have entered into an intergovernmental agreement dated December 3, 2003 where the County agrees to provide $\$ 35,000$ year over a seven year period payable toward the City Hall Complex, and

WHEREAS, it has been determined by staff that a loan from this fund will not jeopardize the City's ability to pay the Northridge LID debt requirements,

NOW THEREFORE, IT IS RESOLVED THAT the City Council of the City of Prineville hereby approves an interfund loan of $\$ 196,500$, from the Northridge Debt Fund to the City Hall Police Upgrade Fund to provide a portion of the financing for the construction of the City Hall and Plaza. The Northridge Debt Fund will be paid back at $1.08 \%$ interest, over a five year period, from the proceeds paid by Crook County. The repayment schedule is hereby attached.
