

**RESOLUTION NO. 966
CITY OF PRINEVILLE**

A RESOLUTION FORMING EAST HIGHWAY 26 LOCAL IMPROVEMENT DISTRICT AND PROCEEDING WITH IMPROVEMENTS AND INTERIM FINANCING.

WHEREAS, by Resolution No. 964 passed April 13, 2004, the Prineville City Council declared its intention to extend its sanitary sewer system from approximately the east "Y" on Highway 26 to approximately Barnes Butte Road to provide sewer service to a number of properties; and

WHEREAS, under said Resolution, notice was to be given to affected property owners; and

WHEREAS, said notice was mailed to each owner of property in the proposed Local Improvement District more than ten days prior to April 27, 2004; and

WHEREAS, a hearing was held on April 27, 2004; and

WHEREAS, residents in the area of the proposed Local Improvement District, who appeared at the hearing, indicated their desire to continue with the Local Improvement District to place said sewer lines; and


WHEREAS, there was no remonstrances against such Local Improvement District only an objection by one proposed property owner of the methodology for allocating the costs of the placement of the sewer lines;

NOW THEREFORE, Prineville City Council resolves as follows:


1. It is hereby declared that the east Highway 26 Local Improvement District is hereby formed. The properties benefited by the proposed sewer line are shown on the map attached hereto as Exhibit A and by this reference made a part hereof and are also shown on the list of properties on Exhibit B attached hereto and by this reference made a part hereof.
2. The City Manager is hereby directed to proceed with the improvements and to obtain interim financing for the project.

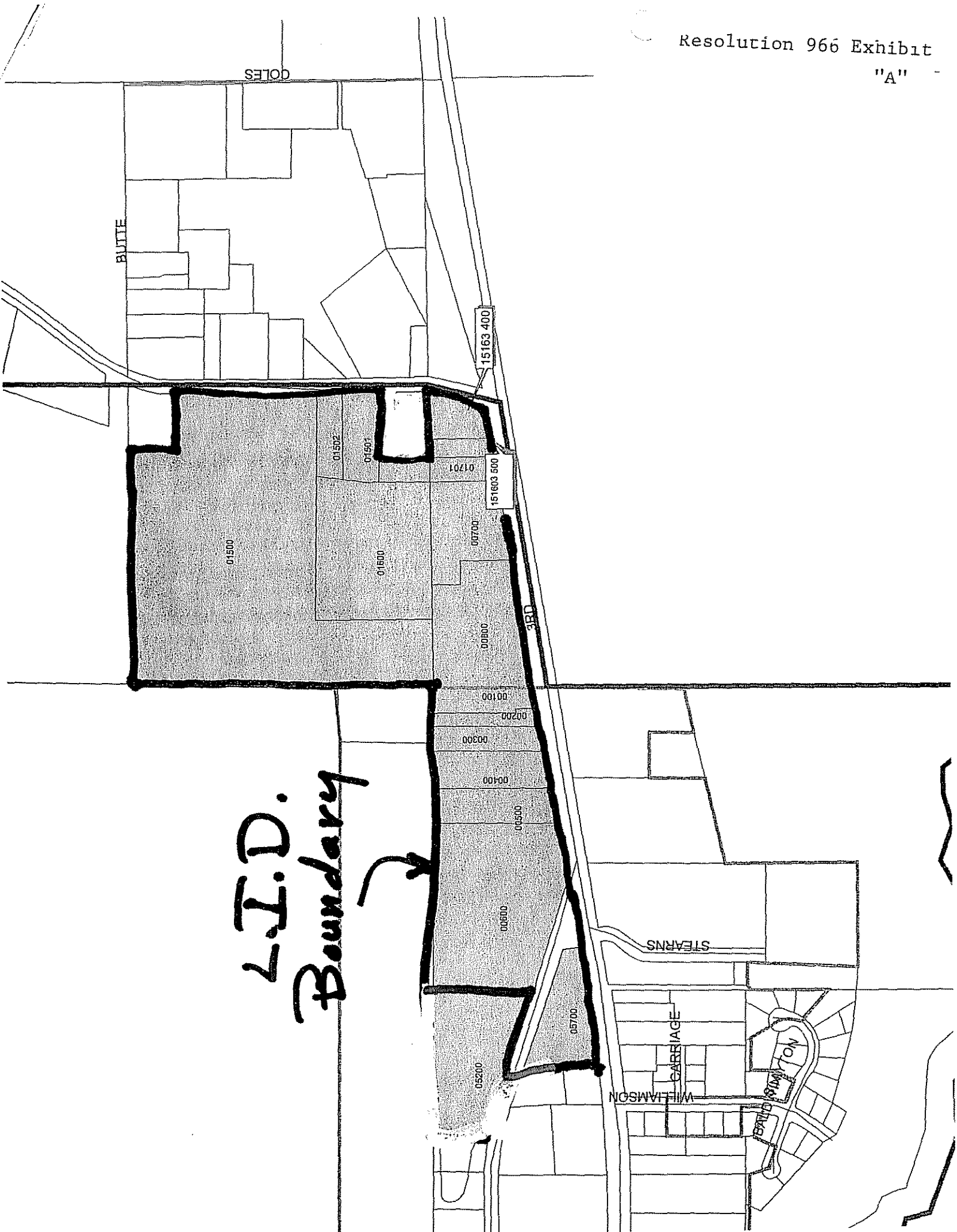
