RESOLUTION NO. 770

A RESOLUTION ESTABLISHING FEES FOR LAND USE APPLICATIONS PROVIDED FOR OR REQUIRED BY CITY ORDINANCES NO.S 805 AND 807

IT IS HEREBY RESOLVED by the Prineville City Council as follows:

- 1. The Council specifically finds that:
- (a) Section 12.080 of City Ordinance No. 805 and Section 9.080 of City Ordinance No. 807 provide that fees required for land use applications provided for or required by said Ordinances 805 and 807 shall be reviewed and set annually by order of the City Council.
- (b) The current fee schedule applicable to such applications has not been reviewed for more than one year.
- (c) ORS Chapter 227.175(1) provides that the governing body of a city shall establish fees charged for processing land use permits at an amount no more than the actual or average cost of providing that service.
- (d) The City Planning Staff and City Planning Commission have reviewed said fees relative to the actual and average costs of processing said applications, and have, as a result of that review, recommended a revised fee schedule for such applications that relates more directly to the actual or average costs of such services than the current fee schedule.

NOW THEREFORE, the Prineville City Council does hereby adopt that Filing Fee Schedule attached hereto as "Exhibit A" to this resolution. Said fee schedule shall be in full force and effect 30 days from the approval date of this Resolution.
