RESOLUTION NO. 597

A RESOLUTION PROVIDING FOR A SPECIAL ELECTION TO BE HELD ACCORDING TO THE STATUTES OF THE STATE OF OREGON AND THE CHARTER OF THE CITY OF PRINEVILLE FOR THE PURPOSE OF ADOPTING OR REJECTING A LEVY OF \$161,000 OUTSIDE THE CONSTITUTIONAL 6% LIMITATION; PROVIDING FOR THE BALLOT TITLE, WHICH SHALL CONTAIN A CAPTION, QUESTION, PURPOSE AND EXPLANATION CLAUSE; PROVIDING FOR TIME AND PLACE OF THE ELECTION:

THE CITY OF PRINEVILLE RESOLVES AS FOLLOWS:

Section 1. A special election to provide for a vote on a Parks, Recreation and Swimming Pool Operating Levy for Fiscal Year 1982-83 in the amount of \$161,000, commencing July 1, 1982, shall be held and the same is hereby called to be held in the City of Prineville, Crook County, Oregon, Tuesday, June 29, 1982. This amount is outside the constitutional limitation.

Section 2. The ballot title under which this proposal shall appear is as follows:

51. PARKS, RECREATION, SWIMMING POOL OPERATING LEVY FOR FISCAL YEAR 1982-83.

QUESTION: Shall City of Prineville levy \$161,000 outside Oregon Constitutional limitation for Parks, Recreation and Swimming Pool operations, Fiscal Year 1982-83?

PURPOSE: The purpose of this levy is to provide the dollars necessary to supplement other Parks, Recreation and Swimming Pool related revenues in order to provide these services to the Citizens of Prineville. This levy will provide the City with funds outside the limitation imposed by Section 11, Article XI, of the Oregon Constitution.

EXPLANATION: As authorized by the Oregon Constitution, the City can levy only \$77,028 in property taxes for the 1982-83 fiscal year and must have specific voter approval for any amounts above this level. In order to provide Parks, Recreation and Swimming Pool services to the Citizens, supplemental tax dollars are needed. If this measure of \$161,000 is approved, it will provide the dollars necessary to provide the aforementioned services. More specifically, the \$161,000 levy will support the following: PARKS - \$89,049. This includes three (3) full-time maintenance personnel plus related supplies and equipment; RECREATION - \$31,778. This provides all instructors, equipment and supplies necessary for recreation programs; SWIMMING POOL - \$45,835. This is for lifeguards, heating, chemicals and maintenance supplies and also includes a new thermal blanket for the pool at night in order to help prevent water heat loss.

If this measure is approved, \$161,000 of the taxes levied in the 1982-83 fiscal year will be financed partially by the State of Oregon.

Section 3. That the City Council deems it advisable and does hereby call and make the necessary provisions for holding a special election which shall be and is hereby called to be held on the 29th day of June, 1982.

The electors voting at said special election shall cast a ballot on the levy outside the constitutional 6% limitation in the sum of \$161,000, which shall contain, in addition to the ballot title,

the words "YES, I VOTE IN FAVOR OF THE LEVY; NO, I VOTE AGAINST THE LEVY," and on which ballot each voter shall mark and cast according to law as each may desire to vote.

Section 4. The City Recorder be and he is hereby instructed to publish a notice of election in full with the ballot title therefor once or oftener within the time period established by statute immediately preceding said special election in the Central Oregonian, the official newspaper of the City, and hereby designated for said purpose, the first publication of said notice to be not less than ten (10) days prior to said election, and by posting written notice of the proposed tax levy outside the constitutional 6% limitation, in the sum of \$161,000 for the fiscal year commencing July 1, 1982 and ending June 30, 1983, in three public places: (1) Bulletin Board, City Hall; (2) Bulletin Board, U.S. Post Office, Prineville; and (3) Bulletin Board, Crook County Courthouse, Prineville, Oregon. The City Recorder shall make such arrangements with the Crook County Clerk as are necessary for the conduct of the election.
