JUNIPER CANYON WATER CONTROL DISTRICT Description of Property to be Annexed

Beginning at a point on the South boundary line of Lincoln Drive north of Tax Lot 13400 running thence North along the East boundary line of Tax Lot 9300; thence West along the North boundary line of Tax Lot 9300 and 9200 to a point in the Northeast corner of Tax Lot 9100; thence West along the North line of Tax Lot 9100 to the Southeast corner of Lot 16 of Melrose Acres (being Tax Lot 6400); thence North along the East side of Lot 16 (including Tax Lot #6300); to the South boundary of Melrose Drive; thence along the North boundary of Tax Lots 6300 and 6400 to the Northwest corner of Tax Lot 6400; thence running North across Melrose Drive to the Southeast corner of Lot 4 of Melrose Acres; thence North along the East side of Lot 4 to the Northeast corner of same; thence West along the North boundary of Lots 4 and 3 of Melrose Acres to the Northeast corner of Lot 2 of Melrose Acres.

Beginning at a point on Combs Flat Road where the present boundary is located; running thence North along Combs Flat Road to a point on the East boundary of the Junior High School enclave where SE 3rd would intersect Combs Flat Road if extended Easterly from its eastern end through Prineville Acres (which street has been vacated); running thence West through the Junior High Enclave and through Prineville Acres along vacated SE 3rd Street, across Idlewood Street and along the North boundary of SE 3rd Street in the Northeast Townsite Co. First Addition (crossing Holly, Garner, Fairview and Elm Streets) to a point in the Southeast corner of Lot 12, Block 5, Oregon and Western Addition; thence North along the East boundary of Lots 12 and 1, Block 5 to the center of the intersection of SE 2nd Street and Elm; thence West along SE 2nd Street to the center of its intersection with South Court Street; thence North to the Northeast corner of Davidson Field; thence West along the North line

of Davidson Field to the Northeast corner of Tax Lot 1600; thence South along Tax Lots 1600, 1700, 1800, 1900, 2000 to the Southeast corner of Tax Lot 2200; thence West along the South side of Tax Lot 2200 and across South Main Street to the Northeast corner of Tax Lot 900; thence North westerly along the North boundary of Tax Lot 900 to a point on the present boundary of the District at the Northeast corner of Tax Lot 2340 (Lot 8, Block 3 of South Prineville Addition); and all of Hamman's subdivision to the City of Prineville.
