Mayor Roppe explained that the Crook County Commission on Children & Families may disappear due to funding; The unofficial homeless count had 230 contacts made; we will have 13 visitors from Sweden to discuss our economics; and we will be going to the Capital in Salem tomorrow for COCO's day in Salem.

B. Managers Report – Steve Forrester

Steve Forrester stated that: we continue to share information with Project Pillar and it is looking positive, legislation on central assessment tax plays a role; Mayor Roppe, Eric Klann, Lisa Morgan and myself are going to Salem to meet with state representatives, law makers and department officials; the Sweden tour will be a good opportunity to share information; Chief Bush, James Wilson, Tobie Reynolds and myself continue to work with Jefferson County on models for 911; and James Wilson was successful in securing a \$40,000 Op Center grant.

C. Intent to Award Proposal for Railcar/Stock Pile Elevator – Toby Van Altvorst

Toby Van Altvorst, Railroad Manager presented the staff report and answered questions.
