#### **Consent Agenda**

#### B. Council Contribution Procedure Discussion –

Mayor Roppe went to Item "A" – Council Contribution Procedure.

Mayor Roppe brought up a few items such as whether or not to have a date to submit applications by so that all requests are in front of them to decide who gets what amount, etc.

There were concerns about an organization not knowing in advance whether funding is needed or not and then missing the opportunity to contribute to a worthy cause.

Council agreed that a workshop should be held to discuss prior to the budget for 2016/2017.

#### A. Manager's Report – Steve Forrester

Mr. Forrester stated: that it appears the Wetland project will receive another \$250,000 from Oregon Watershed Enhancement Board (OWEB); Ochoco Creek Trail is complete except for a few minor details; Crook County Fire District may do a learn and burn where the new Taco Bell will go; planning for the health fair is moving along; there will be a law enforcement memorial flag service on Friday beginning at the court house at 10:30 A.M.
